October 29 Speaker — Dr. Thayumanasamy Somasundaram, India, is the Director of FSU's X-Ray Facility. He was born in India, holds a PhD in Science from Indian Institute of Science, Bangalore, India; speaks 3 languages; is married and has one child; and is widely published. Dr. Somasundaram spoke primarily of South India . He is from an area about 35K from Sri Lanka. The people in that area are very homogeneous and stay in that area, even the same house, for many years. He was the first person in his family to get a higher education. Most of his family members have never been beyond 35 miles from where they were born. South India is, for the most part, outside the political system and has no one to speak for them. They do have a very good educational system. The three major religions of Moslem, Hindu and Christianity are evenly divided at about 33% each. Their food is based on rice, wheat and coffee. They have no air-conditioning. The practice of arranged marriages is very slowly changing, but the caste system which effects marriages is still in practice. There is no need for babysitting because grandparents, aunts and uncles are either living in the same house or very near to take care of children. The difference in the rich and poor is increasing, but the rich realize they need to help and are giving to benefit others.





November 5 Speaker — Fred Varn, Leon County School Board Member and 2008 candidate for District 9 Rep in the Florida Legislature, spoke on "The State of Our Schools." Fred has been a School Board member since 1996, has a Bachelor's Degree in Education and a Masters in Admin and Supervision, is an Adjunct Prof at FSU, and is a Mason, a Shriner, and a member of Tallahassee Kiwanis Club. He is married with 4 children and is employed by the Department of Financial Services. Fred says that the Leon County school system is in "great shape." The annual county school budget is \$500 million and it takes \$956K to run the system daily. Loss of \$1.5 million in the budget may create difficulties. 33K students, speaking 50 languages, are carried to school on school buses that run 4 million miles per year. Those students are provided 22,500 healthy meals daily—no additives and low calorie. There are 9K PCs in the system that operate 2100 network programs. Fred says that the lottery is not providing as much to school budgets as expected; \$2.9 million of the lottery goes to Leon County schools or about 1/4 of one penny (only 23 cents of each lottery dollar goes to K-12 for the entire state). Safety is the #1 priority in Leon schools.

Description of Capital City Kiwanis Club Projects

Roadside Clean-up: Once a quarter, the club goes out on a Saturday morning to pick up trash along a two-mile stretch of U.S. 90 about two miles east of I-10.

Ramp Building: Working with Ability First, the club annually constructs a ramp for disabled or senior clients whose access to their house is limited.

<u>Meals on Wheels</u>: Each week a club member delivers meals from Elder Care Services to about 10 clients on Route G5 (N. Monroe St.) <u>Football Parking</u>: A fund-raiser — members park cars at the Southern Scholarship Foundation parking lot on Stadium Drive during home FSU football games. CCKC splits the proceeds with 60% going to SSF to help provide college scholarships to needy kids.

ECHO: Once a quarter members feed the homeless on weekends at First Presbyterian Church.

<u>Kids Voting</u>: On election day, club members man the Kids Voting booth at a selected precinct to help educate kids on the election process.

Bethany Apartments Support and Kids Christmas Party: The club supports the children of families at Bethany, temporary housing for homeless families. CCKC, with the Moose Lodge, provides dinner and Christmas presents for Bethany kids in December.

<u>Salvation Army Caring Tree</u>: Members man the tree at Governor's Square for a day during Christmas holidays; shoppers pick a name and purchase items needed by the child.

Big Bend Hospice Tree of Remembrance: Members man the tree for a day, and shoppers donate to purchase an ornament to place on the tree in memory or in honor of a deceased loved one.

Alternative Christmas Market: An annual fund-raiser in early December in which the club mans a booth at Christ Presbyterian Church providing shoppers with a list of items supporting a selected club project, such as the Miracle League, from which they can choose items to purchase at various prices as donations.
